Re: F&W Media Inc. / WARN Notification

Dear State and Local Representative:

I am writing to provide you with an update regarding F&W Media Inc. (the "Company") and its various operations. As you may be aware, the Company has experienced a period of financial difficulties that resulted in the Company filing chapter 11 petitions with the United States Bankruptcy Court for the District of Delaware. The Company is currently executing a sale process in the Bankruptcy Court with the goal of selling its businesses, which operate out of the facility (the "Facility") located at 5225 Joerns Drive, Stevens Point, WI 54481, to potential buyers as a going-concern.

If the Company is unable to find and secure a suitable buyer who will continue operations at the Facility, or in the event that certain employees are not offered continued employment by such a buyer, it is expected that the approximately sixty-six (66) employees at the Facility will be terminated sixty (60) days from the date of this notice, or within a fourteen day period thereafter, although this date is subject to change. Any employment terminations will be permanent and employees will not have any "bumping" rights.

Attached is a list of job titles of positions affected by this notice and the names of all employees currently holding the affected positions. We deeply regret and understand the uncertainty this action will cause our valued employees and the community. We will keep you apprised of ongoing developments.

This notice is being provided to you in accordance with any potential notice requirements that may arise under the federal Worker Adjustment Retraining and Notification (WARN) Act and all other similar applicable state and local laws.
