

Section 5.4 Criminal Background Checks (CBCs)

- Required for Service Provider personnel and subcontractors.
- Obtain a criminal history search from the Wisconsin Department of Justice: https://www.doj.state.wi.us/dles/cib/cib-frequently-asked-questions
- For any Non-Wisconsin residents (current or within the last 5 years) conduct a search similar to that of the Wisconsin Department of Justice.

Criminal Background Checks (cont.)

Notes

- Review the Wisconsin Sex Offender Registry at http://offender.doc.state.wi.us/public/home/jsp
- CBCs completed within six (6) months before the signing of the Agreement are acceptable



CBC Reports that Contain Findings

- Service Provider must notify the DVR Contract Specialist within two (2)
 business days when the Service Provider becomes aware that Personnel
 and/or Subcontractors are the subject of an investigation that may lead
 to a conviction that would be substantially related under DVR's criminal
 background policy.
- Additionally, the Service Provider must notify the DVR Contract Specialist within two (2) business days of discovering any new convictions or if an individual has been added to the Wisconsin Sex Offender Registry.



CBC Reports that Contain Findings (cont.)

- Notes
 - oAll CBC reports must be kept on file for three (3) years.
 - DVR reserves the right to request copies of criminal background checks for Service Providers as well as all staff and subcontractors covered by this Agreement at any time.

Invoicing (Section 9.3)

- Invoices must be submitted within 60 days after completion of acceptable service.
- Purchase orders not invoiced within 60 days or service completion may be cancelled.
- Invoice instructions included on all DVR purchase orders.
- Invoices are paid within 30 days of receipt.
- Note: Services performed without an approved purchase order issued <u>before</u> service start date will not be paid



Amendments and Termination

Amendments

- Scope of Work: Provider must give a 30-day written notice to the WDA Director when reducing services or coverage area.
- Expanding services or coverage area requires written approval of WDA Director.
- Change in Provider Name, FEIN, or Address: Requires a 30-day written notice to DVR.

Termination

o Without Cause: Either party may terminate upon 30 day written notice.

Service Agreement Renewal Process

- DVR Service Provider Portal System login: https://webapps.dwd.state.wi.us/dvrserviceprovider/
 - a. Select Federal Tax Classification on Details Page
 - b. Review/Add Communities Served (Details Page)
 - c. Review/Add Service Locations
 - d. Update Personnel/Subcontractor Accounts
 - Locations Served
 - ii. Employment Type
 - iii. Services Provided
 - iv. Specialized training, certification and/or credential(s).
 - v. Training and Criminal Background Check Dates



Service Agreement Renewal Process (cont.)

- 2. Go to Agreement Page & Select Add New Service Agreement
 - a. Select WDA(s) & Services Provided
 - b. Read and acknowledge the following electronic forms:
 - i. Service Agreement Signature Form
 - ii. Certification Regarding Drug-Free Workplace Requirements
 - iii. Certification Regarding Criminal Background Checks
 - c. Check electronic signature box, select SAVE, then SUBMIT
 - d. Agreement Status should read Pending DVR Decision

Note: DVR approval may take up to several weeks.



Process Updates and Deadlines

- April 25 May 13th: Complete Agreement prerequisites and portal updates.
- May 16-May 27th[:] Complete and submit a new Agreement through the service provider portal.
 - Note: Service Providers must complete all updates and submit a new service agreement via the service provider portal by May 27th.
- May 30th-June 24th: DVR reviews and approves Agreements.
- New term begins July 1, 2022 through June 30, 2024.
