Wis. Stat. 103.90-103.97 provides protections for migrant workers who temporarily leave their principal out-of-state residence and come to Wisconsin for not more than 10 months in a year to accept seasonal employment in agriculture, horticulture, or food processing.

The data provided has not been verified by the department. A blank space indicates a lack of response from the employer.

**Non-workers are non-working family members of migrant seasonal farmworkers as reported by employers. The non-worker population does not represent the total number of non-workers in the state.

^H-2A workers are temporary, nonimmigrant workers who are provided a visa to perform agricultural labor or services of a temporary or seasonal nature. Employers obtained certification from the U.S. Department of Labor (DOL) after they demonstrated there were insufficient qualified U.S. workers available and willing to perform the work at wages that meet or exceed the prevailing wage paid for that occupation in the area of intended employment.

This number is the number of H-2A workers who were used by the employer by hiring them directly or through a migrant labor contractor.

^^This number reflects the number of H-2A worker positions that was certified by the USDOL.

The data provided in this report is a record of the department's outreach and enforcement activities and does not purport to provide comprehensive data about the migrant farmworkers in Wisconsin.

The H-2B temporary non-agricultural program permits employers who meet the program requirements to hire nonimmigrant workers to temporarily come to the U.S. to perform non-agricultural services or labor based on the employer's temporary need. The employer must establish that its need for non-agricultural services or labor is temporary in nature, regardless of whether the underlying job is permanent or temporary.
