



Unemployment Insurance Claims Filed*
November 30, 2014 through December 06, 2014
Week 49

Initial Claims

Initial Claims for unemployment insurance increased by 91 to a total of 15,436 for the week ending December 06 (week 49). Last week Initial Claims totaled 15,345. One year ago Initial Claims amounted to 16,940.

Continued Claims

Continued Claims for unemployment insurance increased by 16,829 to a total of 68,817 for the week ending December 06 (week 49). Last week Continued Claims totaled 51,988. One year ago Continued Claims amounted to 80,014.

Insured Unemployment Rate

Wisconsin's unadjusted insured unemployment rate increased to 2.53% during the week ending November 29 (week 48).

***Due to the requirements of the extended benefit programs currently in effect, the data contained in this report represent preliminary values for Initial and Continued Claims.**

Unemployment Insurance (U.I.) Definitions

All Regular Programs

UI - Unemployment compensation for workers insured under Wisconsin's UI Law (Chapter 108 Wis. Statutes)

UCFE - Unemployment compensation for federal employees provided by federal law.

UCX - Unemployment compensation for ex-military persons provided by federal law.

All State and Federal Emergency Benefit Programs

Additional emergency unemployment benefits payable during periods of Wisconsin Supplemental Benefits, (WSB), Extended Benefits, (EB), and/or Emergency Unemployment Compensation (EUC).

WSB - Up to 8 additional weeks are available when the State's Insured Unemployment Rate reaches specific levels to cause WSB to be "ON".

EB - Up to 13 additional weeks are available when the State's Insured Unemployment Rate reaches specific levels to cause EB to be "ON". Wisconsin Statute 108.141

EUC - Additional weeks are available when the National legislation authorizes the payment of emergency unemployment benefits.

Types of Claims

A **New** claim is a request for determination of insured unemployment status for the purpose of establishing a benefit year following a job break.

An **Additional** claim is a claim which reports a job break within an established benefit year.

A **Transitional** claim is a request to establish a successive benefit year dated as of any date in the 7-day period immediately following a week for which benefits were claimed. (This type of claim does not show a new unemployment spell, just a shift between benefit years.)

A **Compensable Week** is a calendar week of unemployment for which UI benefits have been claimed by partially or totally unemployed worker. This claim is also referred to as a **continued claim**.

An **Intrastate** claim is a claim taken in Wisconsin based on work for a Wisconsin employer.

An **Interstate Agent** claim is a claim taken in Wisconsin based on work in another state with benefits paid by the other state.

An **Interstate Liable** claim is a claim taken in another state based on work for Wisconsin employers.

LADT (liable/agent data transfer) refers to claims from residents of Wisconsin taken directly by another state based on work in that state.
